Access Restrictions

Though the majority of the collection does not contain any access restrictions, there are Quarterly Reports in 2012.8.1.6 that give employees' Social Security Numbers.

Accession Note

From 2005-2009, the Park City Museum drastically increased its collections, in part due to the large renovation and expansion project underway. It is uncertain when exactly Hal I. and Marjorie Himes brought these records to the Museum, since there is no definitive Temporary Custody Receipt that refers to their donation, though it was likely in 2006. While staff worked on construction, researching, and writing projects, papers and collections such as these were reserved for an occasion when time and space were available to process them. They were moved to Open Storage in the Hal Compton Research Library in 2009 and remained there until 2012 when they were accessioned.

This collection was comprised of one binder relating to the Park City Miners' Hospital and four binders of Fraser Buck's notes, files and correspondence from the 28 years he was involved with the New Park Mining Company. Because they are all Fraser Buck's papers, they were kept together in the same collection, however, they were given separate series numbers (2012.8.1 – Park City Miners' Hospital, and 2012.8.2 New Park Mining Company, hereinafter referred to as NPMC or New Park).

As with other collections the Himes have donated, these papers came arranged in plastic sleeves in a three-hole binder. Because papers developed various kinds of mold while enclosed in this oxygen-deprived state, they were removed to archival folders and now comprise two 10.5" x 15.5" x 5" boxes.

Archivist's Note

Regarding New Park Mining Company Papers

It is uncertain whether the NPMC papers were originally contaminated with mold, however, the environment in the plastic sleeves accelerated the mold, as evidenced by looking at paired papers which show mirrored mold patterns. Though moldy papers have been cleaned using a High Efficiency Particle (HEPA) vacuum, people handling these papers (especially 1940-1957, 1959) must wear gloves and avoid contact with their eyes. It is highly recommended visitors wear a mask, though this is at their own discretion. Some papers appear to have been

cut (perhaps to fit inside plastic sleeves). It is uncertain if Fraser Buck himself or Hal or Marjorie Himes did this initially or to fit papers into the plastic sleeves. (See Appendix A for photos of the different kinds of mold.)

A copy of the May 18, 1951 *Western Mineral Survey* newspaper was mailed to the Utah State Historical Society after making a copy of the featured New Park article for the file.

Park City Miners' Hospital

History

Ground was broken for the Miners' Hospital on April 28, 1903, and it opened on October 1, 1904. Its articles of incorporation stated "the object of this incorporation is not for pecuniary profit, but is and shall continue to be for charitable purposes only." In particular, the institution's purpose was to furnish hospital care, medical and surgical attention and to treat sick, injured and afflicted persons. The community bought stock from the Miners Union in order to get the much-needed hospital on one acre of land donated by Eliza Nelson. For a modest \$1 per month, miners and non-miners alike could have access to the hospital. The facility functioned as a public welfare institution and, for the first five or six years, the hospital prospered.

Even so, problems with the management and operation of the organization began to surface. During the fall of 1919, the mining companies showed disinterest in the hospital and many miners did not pay their monthly dues of \$1. The three doctors on staff tried to keep the hospital open, working without pay so patients could receive needed medical attention. Despite these efforts, the hospital's board of directors decided to close the doors on November 1, 1919. The Miners Union supported this decision, stating that every effort to keep the facility open had been made but the support of the workers themselves was not there.

Quickly, conditions returned to the way they were before the hospital was built, with patients waiting over 24 hours before they could go to medical facilities in Salt Lake City. Death and suffering for injured workers increased. In early 1920, the mining companies agreed to open an emergency hospital in the first floor of the New Park Hotel. The hospital's board of directors purchased new supplies and the hospital opened. Margaret Clarke also ran a maternity hospital in a house on Woodside Avenue during this time.

Still, the town needed a full and modern hospital and the Miners' Hospital building was vacant and deteriorating. Clarke purchased the Miners' Hospital building in 1922 and became

manager of the institution. The mining companies supported Clarke and even donated all the equipment from the emergency hospital at the New Park Hotel. The hospital was completely renovated and the latest surgical appliances were purchased, including an X-ray machine and new heating system. It was during this renovation that the “sunshine room” was created, which was the light and airy top floor of the building. The hospital doors were reopened on September 18, 1922.

The price list in 1922 for the Miners’ Hospital was a bargain compared to today’s medical prices. Hospital subscribers could expect free services from doctors either at the hospital or at their offices, free medicine with a prescription except for serums or antitoxins, no charge for minor operations and only a nominal fee for X-rays. The room rates for patients were \$20 per week in a ward and \$30 per week for private rooms. The Miners’ Hospital had a beautiful setting on the side of the hill where the Shadow Ridge Hotel is located today. In several *Way We Were* articles, particularly by Hal Compton, it was written that by the mid-1950s, the building was rundown, obsolete and was closed, later becoming a skier’s flop house and a saloon. However, these papers show that wasn’t the case.

Faced with the closure of the Miners’ Hospital in 1949 and the loss of medical care in the city, Lennie N. Schlup, R.N., the nurse supervisor, purchased the hospital and continued as its owner until her retirement in 1964. Fiercely devoted to her work, Lennie often remained at the hospital providing 24-hour service. When she sold the hospital to a Salt Lake City physician, Dr. William Orris, she did so with the understanding that it would remain a medical facility and provide a full-time doctor. In *Way We Were* articles from October 6, 2004 and September 16, 2009, Bea Mayes and David Hampshire, respectively, correctly reported that the hospital committee reported to the City Council on March 18, 1965 that the hospital had not had a license for about two years and that it would cost more to renovate the present hospital than to build a new one. Though they recommended that the city ask for bids on a new hospital, the *Park Record* announced the hospital would close its doors on July 12, 1965. However, two weeks later, the *Record* reported Dr. Orris would in fact stay. He continued until early 1968 when he closed the doors after trying to find a lessee for the hospital, and moved to the southwest. Lennie died on November 14, 1977 in Akron, Ohio.

The building later became the Palace flop house for ski bums and the White Mule Saloon. After years of neglect and hard use, the beloved Miners’ Hospital was faced with demolition. It was saved by preservationists and in 1979 the historic building was carefully moved to the City Park. There it was renovated and restored to become the City Library in 1982. The Library

moved out in 1993 and has been used by various non-profits, including by City Hall during its Marsac Building renovation. On October 5, 2009, the Park City Medical Center opened to the public, bringing a full-service hospital to Park City once again.

These records focus on the difficult time from 1959 to 1964, while under Lennie N. Schlup's management.

New Park Mining Company

History

The New Park Mining Company was the result of a consolidation between the Star of Utah Mining Company, the Park Galena Mining Company, and the Mayflower Mines Corporation. The consolidation culminated in the incorporation of the New Park Mining Company in Nevada, in May 1932. A portion of this collection contains records from 1931 prior to the merger.

In early 1932, Star of Utah and the Mayflower Mines Corporation were deep in debt and could no longer continue their development efforts. At the same time, a large portion of the Park Galena Mining Company was held in trust by the Glenallen Mining Company subject to payment on the title. During the consolidation and incorporation efforts, the newly appointed Board of Directors of New Park Mining Company accepted a proposition by Moore to acquire the title to the Superior Group of mining claims, subject to an unpaid balance on the purchase price. Essentially, the consolidation solved many of the economic issues that stressed these predecessor companies.

The function of the New Park Mining Company was to mine ore containing gold, silver, lead, zinc, and copper. By the 1950s, the company held 5,100 acres of patented and leased mineral rights in the Blue Ledge and Snake Creek mining districts, and Wasatch and Summit Counties, as well as 5,000 acres of claims in the Park City district. New Park Mining Company also owned nearly 20% of Oil Incorporated, with holdings in Utah, Wyoming, and Colorado.

Throughout its years of activity, the New Park Mining Company saw many staff turnovers due to military conscription, injury, and economic conditions (the Mine essentially shut down from the end of March 1949 to September 1949, thus a lack of records during this time). However, the President and General Manager did not change. William Henry Harrison Cranmer (known as W.H.H.) served during the entire length of the company's existence. Other top-level employees included Clark L. Wilson, Vice President and Manager of Operations; R.C. Wilson, Treasurer; and, the owner of these NPMC records, Fraser Buck, Secretary to the Board. Robert L. Cranmer (son of W.H.H.) was General Counsel as well as Secretary. Despite being a previous owner, Charles Moore appears in correspondence with Buck, concerned and interested in the New Park's development.

The company was located in Keetley, Utah, which now sits beneath the waters of the Jordanelle Reservoir. Through 1955, the company produced 1.25 million tons of ore, more than 300,000 ounces of gold, more than 8 million ounces of silver, nearly 15 million pounds of copper, nearly 121 million pounds of lead, and nearly 155 million pounds of zinc. New Park Mining Company produced more gold at the time than any other mine in the district.

The company's management engaged in many union negotiations during its active years. The International Union of Mine, Mill and Smelter Workers as well as Park City Mine & Mill Workers Union No. 99 regularly corresponded with management on a number of issues. Over the years, the unions and management tangled over wages, the amount of control the unions

would have in the mines, and more. However, unlike many companies during their span, New Park Mining Company enjoyed a mostly collegial relationship with the unions.

The company had many stockholders over the years, but during the flush years of the early 1950s, their numbers held in the 3,000s. Their stock transfer agents were the Irving Trust Company of New York; First Security Bank of Utah in Salt Lake City; American Trust Company in San Francisco; and Wells Fargo Bank and Union Trust Company in San Francisco. The majority of the stockholder records are either Irving Trust Company or First Security Bank of Utah documents.

In 1957, depressed metals prices led the mine to briefly close. However, the miners developed a unique plan to keep the mine working (and keep receiving paychecks). They leased the mining company from its owners and pegged their wages to their productivity. As a result, 100 workers were able to earn wages and keep the New Park Mining Company in the black. This agreement was not popular with everyone, as can be seen in the lawsuit the United Steelworkers of America brought against New Park in 1958, but it continued until December 1961.

This collection's records end in 1959, however in December 1961, W.H.H. Cranmer announced to the company's stockholders that the company had contracted with Hecla Mining Company of Wallace, Idaho to take over the management of the Mayflower Mine portion of its holdings. For 11 more years, Hecla operated the mine, paying New Park Mining Company a minimum of \$100,000 annually. Meanwhile, New Park got into the oil service business. In 1972, Hecla pulled out, and New Park Mining Company changed its name to Newpark Resources, Inc., and moved its corporate headquarters to New Orleans, selling some of its surface rights to Lon Investment Co.

Scope and Content Note

The collection is organized into two series:

- *Park City Miners' Hospital (1)*
- *New Park Mining Company (2)*

Both series' papers are organized by accession number, then by series, and folder number. The Miners' Hospital:

Both series are organized chronologically. Since Fraser Buck was the secretary of the Board of Directors, these documents provide insight into finances and business during the last years of the Miners' Hospital and intimate details of the individual mines and consolidation into the New Park Mining Company.

Park City Miners' Hospital

The Miners' Hospital records comprise approximately 0.046 cubic feet of documents, and span from June 1959 to September 21, 1964. There are no documents from 1963. The binder the documents came in was labeled "Fraser Buck's Papers, Park City Miner's Hospital." A title

page of sorts inscribed with “Park City Miners Hospital” appears on medical tape, covered with scotch tape. There are many versions of the spelling of the Miners’ Hospital (Miners, Miner’s, Miners’), but “Miners’ Hospital” is used here due to its spelling in stationary during this time.

The collection is composed of Board of Directors meeting minutes, hospital financials, including profit and loss statements (show how they were spending and taking in money), and personnel (includes quarterly reports that give wages and State, FICA, and Federal taxes taken out from total wages). There are also hand-written patient hospitalization reports by Ms. Schlup, and notes on keeping the books.

Though most of the papers have been neatly placed and preserved in plastic sleeves, there does not appear to be any order, chronological or otherwise, to the documents. The format of the majority of the materials is textual, handwritten and typed, assumedly by Lennie Schlup or Fraser Buck. Additionally, there are three sheets of oversize ledger paper giving employee wages and taxes.

New Park Mining Company

The New Park Mining Company records comprise approximately 0.9 cubic foot of documents, and span from 1931 to 1959. They include correspondence, financials (bills, insurance, invoices, audit), stockholder information (annual reports and cutouts from annual reports), and newspaper articles featuring NPMC.

While this series is not voluminous, its value is high. Such significant materials include papers from the end of Charles Moore’s reign, and the change-over as companies consolidated to become New Park Mining Company. In particular, this includes frank and folksy correspondence between Moore and Fraser Buck, with whom Moore did business (Welsh, Driscoll & Buck) and was part of the mining company as times became tougher and people faile to pay on shares (and Buck’s store) due to the Depression (even to the point the company contemplated folding). The company also owed money to companies who reached the point of turning off utilities and threatening litigation to collect on accounts past due. This collection, beyond giving valuable insights into behind-the-scenes business of the Star of Utah and Mayflower Mines (in addition to the Bonanza Gold Mines Corporation, the Flagstaff Bonanza Mining Company, and later on in 1932, the Park Galena Mining Company), shows the desperation of two businessmen—Moore and Buck—who tried to meet financial obligations during the Great Depression. Moore made many references to being thrown in jail, whether due to his debts, failures, or disagreements with the government. Consolidation seemed the

only way to continue production. Despite a scandal regarding brokers offering to buy stocks, opinions began to change in 1933 with President Franklin D. Roosevelt's "New Deal for Silver," which expressed a "marked increase in the use and value of silver." At the height of the Depression, this was welcome news to miners and shareholders alike. However, Moore didn't leave without giving his two cents on the matter, as expressed in a very colorful August 5, 1933 letter to NPMC Secretary J.F. Featherstone, about a report that he would sell his stock, and in which he tells of his poor opinion of Roosevelt.¹ He also gave his opinion to Buck in an August 14, 1933 letter that Buck should "take the presidency" of the company. That did not happen, of course, as correspondence from W.H.H. Cranmer shows, offering his services to NPMC in 1933. The company did turn around, and in short order, as the Stockholder letter remark from Cranmer explained that two-thirds of floating company debts had been paid off, and the Company had spent over \$10,000 on mine development.

Arrangement Note

The records filled five binders (1 – Miners' Hospital, 4 – NPMC) and were filed into plastic sleeves. While this was a nice way to view the records, the lack of oxygen (in addition to some presumed precipitation either in the records or plastic sleeves initially or at some point) led to mold and water damage and led to the removal of all documents into folders. Hal and/or Marjorie Himes placed these documents in sleeves, so original arrangement had been lost. Therefore Miners' Hospital records, financials, patient summaries and board meeting minutes were placed chronologically into seven folders. The small number of documents played a role in this decision, as it will not take much time to look through the collection to ascertain needed information. The only exception to this arrangement is Miners' Hospital payroll lists for all years, which are in a separate folder because of access restrictions due to Social Security Numbers. Many of these were undated (apart from their quarterly labels), so were kept in the order they were placed in the binder.

¹ He spoke of his distaste for NIRA, or the National Industrial Recovery Act, enacted June 16, 1933, which authorized the President to "regulate industry and permit cartels and monopolies in an attempt to stimulate economic recovery, and established a national public works program." He finishes his letter with "I am going to do my own thinking as long as I live, and all these fanatics can just go to hell, as far as I am concerned."

The four binders of New Park Mining Company papers were organized by the Himes in chronological order, and they remain this way, placed into folders according to original binder, then by day, month and year. They were also removed from their plastic sleeves. (Sleeve brands and varieties ranged from K & M Division Poly-Vu #PV119 and #PV119G, Avery PV119, C-Line #62028 Non-Glare Topper and 20th Century Plastics Stock # CPRBPM-00.) Binder 1 was “New Park Mining Company, 1931-1934, vol.2,” Binder 2 was “New Park Mining Company, 1935 – 1943, vol.3,” binder 3 “New Park Mining Company, 1944 – 1953, vol.4,” and binder 4 “New Park Mining Company, 1954 – 1959, vol.5.”

Throughout the NPMC binders, newspaper articles were pasted to cardstock. Due to their acidic nature, these pages were photocopied and placed in their original order within the folders (and the originals thrown away). One photograph of Charles Moore with these newspapers was removed and placed in an HD PolyChron sleeve. Envelopes accompanying letters were placed immediately before the related letter. Acidic carbon copies and telegram papers have been interleaved with acid free paper. Pins and paper clips remained when not rusted or harming the papers. Several paperclips had already been removed before being placed into the plastic sleeves. Wherever original order was not maintained, a note documents where a document was moved or where it exists despite its placement in the seemingly incorrect year.

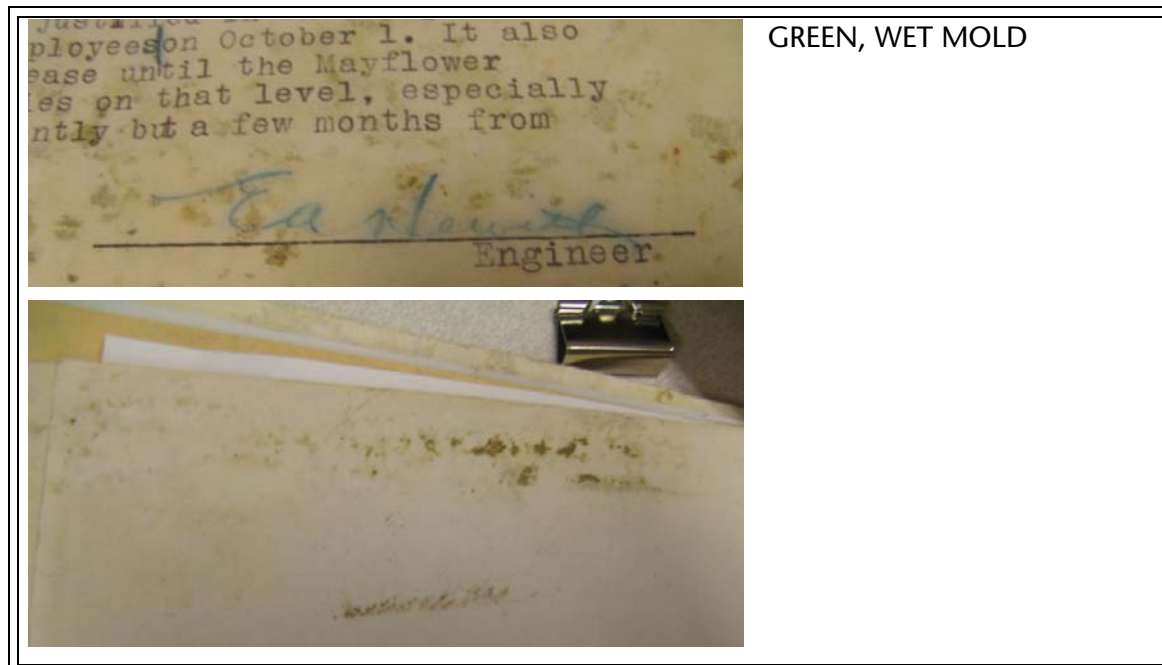

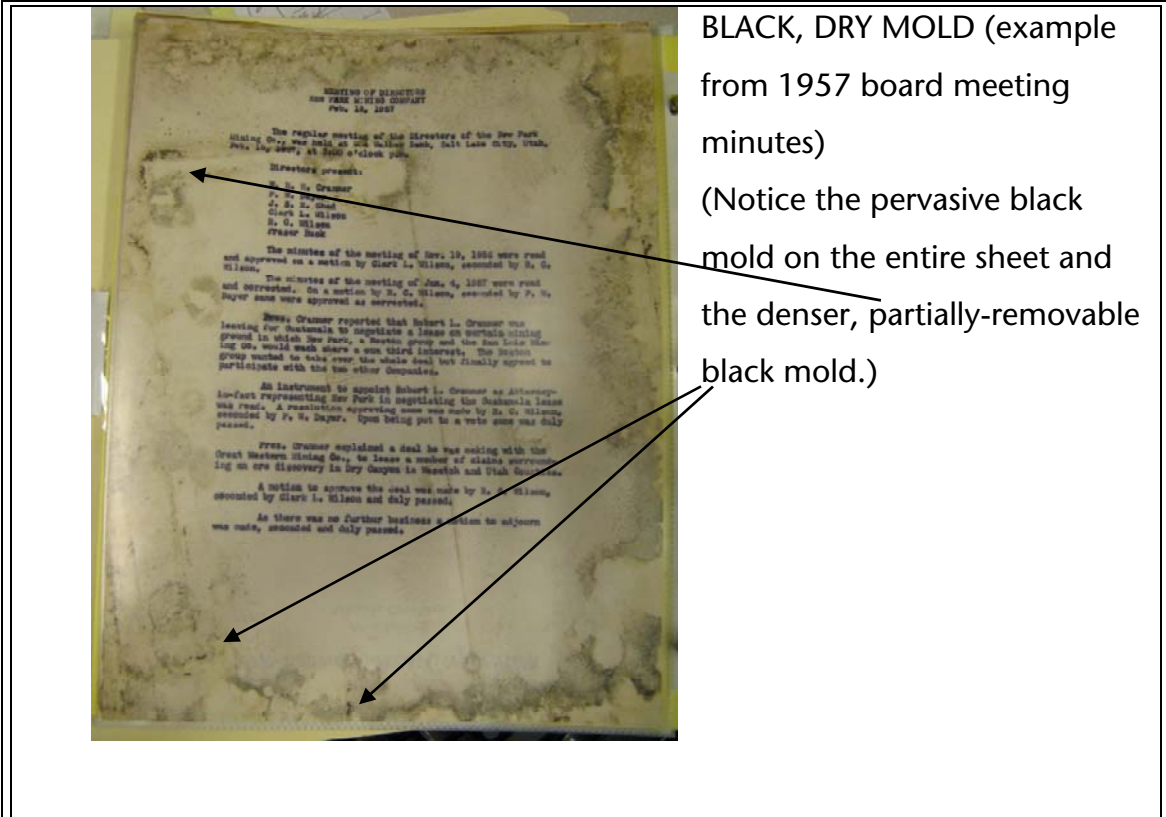
Note on Molds present in New Park Mining Company Papers

The most common mold encountered was a putty-like or wet, green mold. When vacuumed, the bulk was easily removed, but if the HEPA vacuum head brushed the mold across the paper, it left a smeared line, that remained leaving a faint trace of army green on the paper.

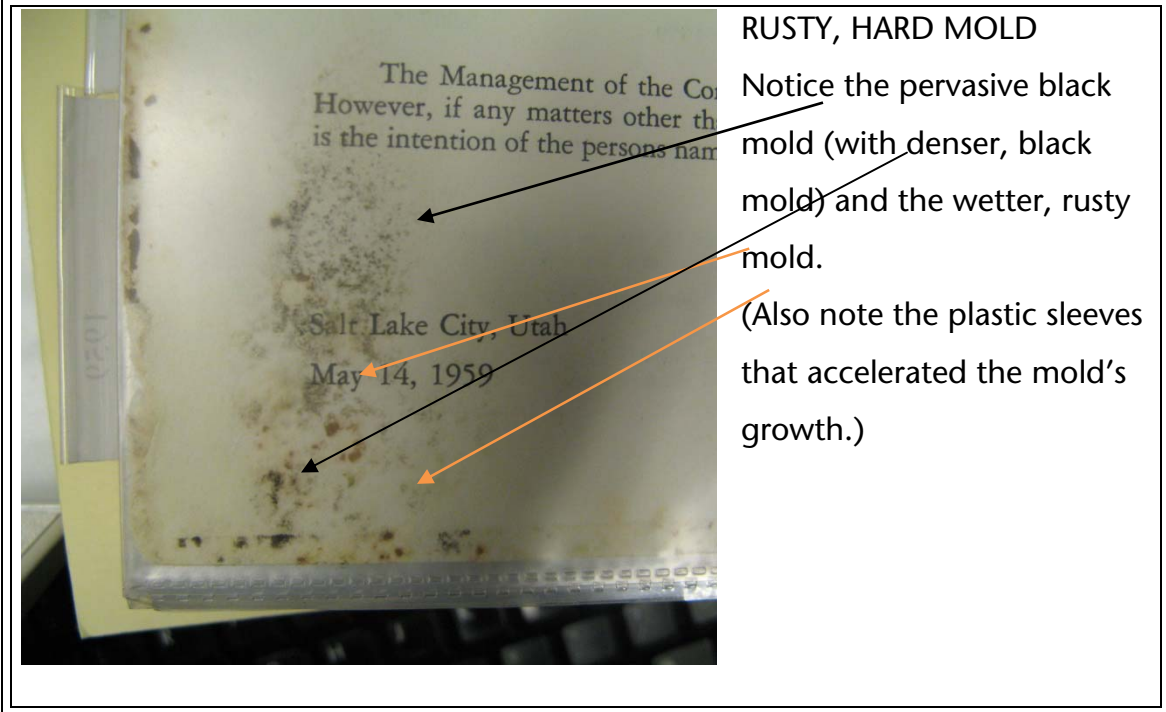
The second-most common mold was a hard, set, black mold that permeated the paper, making it delicate and brittle. While the green and rusty molds often appeared in folds and cracks, the black mold is present on entire sheets of paper, likely due to water damage. Though trace amounts may have been removed, this mold saturated these papers so completely it has become permanent. (There were instances of a much darker, denser black mold that did lift off when vacuumed, though this was the minority of this pervasive mold.)

The third kind of mold observed was a rusty, brown-colored mold somewhere in-between the wet-natured green mold and the set, permeating black mold. It was the least common and most often occurred in between folded paper and in most instances, in the presence of one or the other molds. It was vacuumed with medium success.
