About James L. Hewitson:

James "Jim" Hewitson was born in Park City in 1947. He attended the Marsac School as a child and received his degree in Mining Engineering at the University of Utah. He followed in both his father and his grandfather's footsteps and worked for a time in the Silver King Mine. He worked for United Park City Mines from 1965 to 1972. After the mines closed, he left Park City to find work. He returned to Park City after retirement.

About the James L. Hewitson Collection:

This collection is made up of books and papers related to various mines in Park City. It includes correspondence, financial records, employee records, legal papers, annual reports, stock certificates, and other miscellaneous reports and documents related to mine and mill operations in the area.

A significant number of books and papers in this collection are from W. Mont Ferry's personal library. There are a number of volumes of the transcript on appeal concerning the 1907 lawsuit between the Silver King Coalition Mines Company and the Silver King Consolidated Mining Company.

The majority of the material relates either to the Daly Judge and Daly West mining companies or to the Silver King Coalition Mines Company. Other companies represented in this collection include: the Ontario Silver Mining Company; Park Utah Consolidated Mining Company; United Park City Mines; Anchor Mining Company; Park City and Midnight Sun Mining Company; Snake Creek and Tunnel Company; and the Hawkeye-McHenry Company.

Persons represented in this collection include John Daly, George Lambourne, Solon Spiro, and W. Mont Ferry.

Collection spans almost entire mining history of Park City.
