Access Restrictions

The records of the New Park Mining Company contain personnel records that are restricted in accordance with applicable law. Restrictions where applicable are noted at the series, subseries, or file levels.

This collection is located off-site. 48-hours advanced notice is required for use.

History

The New Park Mining Company, like many mines of the time, was the result of a consolidation between the Star of Utah Mining Company, the Park Galena Mining Company, and the Mayflower Mines Corporation. The consolidation took place over several months, culminating in the incorporation of the New Park Mining Company in Nevada, in May 1932. A portion of this collection contains records belonging to these predecessors as well as other companies invested in, acquired by, or connected to the New Park Mining Company, including the East Utah Mining Company.

One of the major participants in the consolidation was the charismatic Charles Moore, who owned and managed the Star of Utah Mining Company. His correspondence with the stockholders of the Flagstaff Bonanza Mining Company reveals his persuasive personality.

In early 1932, Star of Utah and the Mayflower Mines Corporation were deep in debt and could no longer continue their development efforts. At the same time, a large portion of the Park Galena Mining Company was held in trust by the Glenallen Mining Company subject to payment on the title. During the consolidation and incorporation efforts, the newly appointed Board of Directors of New Park Mining Company accepted a proposition by Moore to acquire the title to the Superior Group of mining claims, subject to an unpaid balance on the purchase price. Essentially, the consolidation solved many of the economic issues that stressed these predecessor companies.

The function of the New Park Mining Company was to mine ore containing gold, silver, lead, zinc, and copper. By the 1950s, the company held 5,100 acres of patented and leased mineral rights in the Blue Ledge and Snake Creek mining districts, and Wasatch and Summit Counties, as well as 5,000 acres of claims in the Park City district. Additionally, New Park Mining Company owned nearly 20% of Oil Incorporated, with holdings in Utah, Wyoming, and Colorado.

Throughout its years of activity, the New Park Mining Company saw many staff turnovers due to military conscription, injury, and economic conditions (the Mine essentially shut down from the end of March 1949 to September 1949, thus a lack of records during this time). However, the President and General Manager did not change. William Henry Harrison Cranmer (known as W.H.H.) served during the entire length of the company's existence. Other top-level employees included Clark L. Wilson, Vice President and Manager of Operations; R.C. Wilson, Treasurer; and Fraser Buck, Secretary to the Board. Robert L. Cranmer (son of W.H.H.) was the General Counsel as well as Secretary.

The company was located in Keetley, Utah, which now sits beneath the waters of the Jordanelle Reservoir. Through 1955, the company produced 1.25 million tons of ore, more than 300,000 ounces of gold, more than 8 million ounces of silver, nearly 15 million pounds of copper, nearly 121 million pounds of lead, and nearly 155 million

pounds of zinc. New Park Mining Company produced more gold at the time than any other mine in the district.

The company's management engaged in many union negotiations during its active years. The International Union of Mine, Mill and Smelter Workers as well as Park City Mine & Mill Workers Union No. 99 regularly corresponded with management on a number of issues. Over the years, the unions and management tangled over wages, the amount of control the unions would have in the mines, and more. However, unlike many companies during their span, New Park Mining Company enjoyed a mostly collegial relationship with the unions.

The company had many stockholders over the years, but during the flush years of the early 1950s, their numbers held in the 3,000s. Their stock transfer agents were the Irving Trust Company of New York; First Security Bank of Utah in Salt Lake City; American Trust Company in San Francisco; and Wells Fargo Bank and Union Trust Company in San Francisco. The majority of the stockholder records are either Irving Trust Company or First Security Bank of Utah documents.

In 1957, depressed metals prices led the mine to briefly close. However, the miners developed a unique plan to keep the mine working (and keep receiving paychecks). They leased the mining company from its owners and pegged their wages to their productivity. As a result, 100 workers were able to earn wages and keep the New Park Mining Company in the black. This agreement was not popular with everyone, as can be seen in the lawsuit the United Steelworkers of America brought against New Park in 1958, but it continued until December 1961.

For the most part, this collection's records end here, however in December 1961, W.H.H. Cranmer announced to the company's stockholders that the company had contracted with Hecla Mining Company of Wallace, Idaho to take over the management of the Mayflower Mine portion of its holdings. For 11 more years, Hecla operated the mine, paying New Park Mining Company a minimum of \$100,000 annually. Meanwhile, New Park got into the oil service business. In 1972, Hecla pulled out, and New Park Mining Company changed its name to Newpark Resources, Inc., and moved its corporate headquarters to New Orleans, selling some of its surface rights to Lon Investment Co.

Scope and Content Note

This body of corporate records includes records of the Cardiff Mining and Milling Company, Flagstaff Bonanza Mining Company, General Connor Mining Corporation, Gold Queens Mines Corporation, American Flag Mining Company, Park Flag Mining Company, Park Galena Mining Company, Glencoe Gold & Silver Mining Company, and Glenallen Mining Company, all of which were associated with the New Park Mining Company in some capacity, either as a predecessor or as an investment.

These records comprise approximately 120 cubic feet of documents, and span from Glenallen Mining Company predecessor's Glencoe Gold & Silver Mining Company's legal dispute with William M. Curtis in 1893 through the conscription of soldiers to work in the mine during the 1940s, through the company's expansion into the natural gas and oil markets in the 1950s, through the eventual takeover by the Hecla Mining Company. Additionally, a small subseries of correspondence among family

members of the Rixey and Wright families between 1943-1974 came in as part of the accession, but no relationship between the Rixey and Wright families and the New Park Mining Company could be determined. Dave Uhlendorf is a collector, and may have picked up these letters and records at another time, storing them mixed with the New Park Mining Company records. However, several folders of materials accompanied the collection, therefore it was processed as if part of it.

The collection is composed primarily of correspondence, financial documents, mining records, personnel documents, and stockholder information. The correspondence originates mainly in the offices of the high-level management of New Park Mining Company, and comprises responses to inquiries regarding billing, and union negotiations, among other topics. The financial documents make up more than half the collection. These records comprise payroll checks, duplicate payroll checks, vouchers, duplicate vouchers, purchase orders, and other corporate billing. The personnel records include mining injury and absence reports, benefits and insurance documents, lists of workers, and more. The stockholder information comprises lists of stockholders, proxies, and correspondence relating to annual reports and dividends.

The format of the majority of the materials is textual and in either letter or legal-sized documents. There also are oversized, paper-based documents that include maps and work reports. Additionally, there are ledgers, checkbooks, small union booklets, and printers' blocks, which as of this time have not been identified.

The collection is organized into seven major series:

- **General Files,**
- **Oversized Items,**
- **Ledgers,**
- **Purchase Orders,**
- **Vouchers,**
- **Checks, and**
- **Proxies**

General Files are divided into a number of subseries based on subject, creator, or document type. These documents provide the history of the company and its workers, a record of union negotiations, legal documents, and highly detailed information about how and where the company mined its metals. A significant portion of the documents are restricted in use due to the presence of Social Security Numbers (on personnel documents as well as tax forms).

Oversized Items include maps, financial documents, work reports, shareholder information, printers' blocks and mining plotting maps among other items. It is unclear how the blocks relate to the rest of the collection since there is no accompanying information or documentation.

Ledgers contain two work diaries that provide a fascinating day-to-day accounting of work done in the mines. Additionally, the Ledgers series includes a book listing stockholders and their holdings, a book displaying workers' wages, union agreement booklets, and checkbooks. The Purchase Orders contain purchase orders and a minimal amount of accompanying material.

Vouchers contain the actual vouchers as well as their originally attached, accompanying materials. These can range from invoices to handwritten letters.

Checks include cancelled checks, payroll check duplicates, bank statements, and other duplicate checks. The Proxies comprise signed proxy documents returned to New Park Mining Company from stockholders. The Printer's Blocks series contains an incomplete set of wood-based blocks with metal forms dealing with financial information.

In addition to the historical information regarding the New Park Mining Company and its predecessors and other associated companies, the collection offers insight into how mines are constructed and the types of work performed in a metals mine during the first half of the twentieth century. Additionally, the collection provides significant details of union negotiations over the course of 30 years. The collection also shows how mining injuries were handled, reported, and analyzed, as well as how mine safety in general was addressed. Importantly, the collection provides a record of soldiers who were sent to the mines instead of to war during World War II. It also provides lists of employees of the mine through the payroll lists, injury reports and payments, as well as checks. Of consequence are the many geophysical surveys and hand-drawn color maps throughout the collection. They provide an extensive look at the geography and geology of the Park City area. The materials mined, their percentages, and smelting settlements are of particular importance for those interested in tracking the metals mined in the area over time. The underground costs and other financials are useful to see how prices rose over time.

Significant gaps in documentation exist throughout the collection, however, the files of W.H.H. Cranmer are especially revealing regarding union negotiations, stockholder relations, and business management in general.

Arrangement Note

While some of the record series and sub-series displayed an inherent arrangement scheme, much of the organizational structure of this collection was necessarily imposed during processing. This reordering and sorting was due to the manner in which the donor transported and stored the records. Series have been grouped to keep like items and subject areas together. Additionally, in some areas, such as Vouchers and Checks, items were arranged by number first, chronological order second.

During the arrangement process, six boxes of newsletters, reports, and other publications that lacked unique New Park Mining Company-related information and did not fall under the collecting policy of the museum were deaccessioned to the Utah State Archives. These publications included *Salt Lake Stock Exchange Reports*, *E & MJ Metal and Mineral Markets*, *Mining News*, *American Mining Congress*, *Utah Mining Association*, *Management Digest*, *Utah Employment Bulletin*, *Utah Metal Mine Operators Association*, *Whaley-Eaton Service Newsletter*, *Utah Employment Security Digest*, *Utah Newsletter*, *Utah Economic Business Review*, *Lead Industry Association*, and *Accountant's Weekly Report*.

Subseries 7. W.H.H. Cranmer's Correspondence

Folders contain handwritten and typewritten letters to and from New Park Mining Company's President, W.H.H. Cranmer regarding mining claims, union negotiations, labor relations, stock dividends, and personal information. During 1946-1947, there is a particularly lively and intimate correspondence with Fred R. Koehler, a Board member. Topics covered include silver prices, the East Utah Mining Company (and a potential sale), a board of directors meeting, and their travel. The January 22, 1947 letter from Cranmer to Koehler discusses Koehler's resignation from the Board of Directors. It also paints a picture of Cranmer's thinking regarding the company's struggles over time and a law suit from the union. Additionally, in 1942, a document proposing increased production includes handwritten notes from Cranmer expressing his displeasure with the International Union of Mine, Mill and Smelter Workers and their tactics.

These ledgers are actually daily work diaries, divided into day and night entries. The handwriting reveals different authors. Locations are given in numerical form, expressing the depth within the mine as well as the orientation. Activities described include mucking, blasting, scraping gob, pulling chutes, timbering, grizzlies, and laying floors. The progression of the interior mine construction as well as the mining activities can be followed through these journals. Additionally, notes written from the day to the night author (and vice versa) describe various conditions and situations such as leaving carts and motors in specific areas. In one journal, the authors name each other by first name. It also appears that the authors switched shifts at times.

These agreements cover hours/days of work, working conditions, contract facts, and wages. The remaining two booklets are between other mining companies and unions. One is between the Anaconda Copper Mining Company, Darwin and Shoshone Mines, and the Coso Mine, Mill and Chemical Workers Union No. 841 of the International Union of Mine Mill and Smelter Workers. The other is between the St. Joseph Lead Company and Mine La Motte Corporation, and Lead Workers' Local No. 404 Affiliated with United Gas, Coke and Chemical Workers of America, C.I.O. These two agreements cover the same ground as the previously mentioned booklets.

The materials in these boxes are New Park Mining Company General Vouchers that span from June 1941 to 1958. These are paid voucher checks stapled to corresponding bills, and each expense distributed to different categories. Categories include accrued payroll, time checks, p/r deductions, inventory—supplies, Gold Queen development, mine building, mine machinery and equipment, mining claims and property, miscellaneous abstracts, accounts receivable, Shower & Bower unit, Lost Sheep Unit, prepaid insurance, workman's compensation insurance Payable, reserves for taxes, mine supplies, R&R mine machinery, mine overhead, surface maintenance, general expense, office supplies and expense, Salt Lake Office Expense, taxes, engineering and surveying, group insurance, director fees, leased and other property expense, legal and auditing, Star of Utah Development. They also include hospitalizations and doctors visits.

All original bills are attached to the vouchers, and some original correspondence is as well. These items are sorted chronologically and numerically. Since all of these vouchers are business expenses and not personnel checks, there are no access restrictions.

*Archivist's Note: Researchers may notice overlapping of dates and voucher numbering among folders. While still valuable in telling how the New Park Mining Company did business, these vouchers were re-housed and labeled as limited time and resources allowed.

Series 8. Rixey and Wright Family Papers [1 box]

This series consists of correspondence, school papers, and memorabilia associated with the Rixey and Wright families between 1943 and 1974. Items are arranged first by family name and then by year in separate folders. Individual items in folders are arranged chronologically within a given year. Undated materials from each family's body of papers are in separate folders after each grouping of dated family papers. The school papers found with the correspondence might have belonged to Walt Rixey, but there is no name or date on them, and they are in a separate folder after all other family correspondence.

There is no clear connection between the Wright and Rixey families, or between either family and the New Park Mining Company. The Wrights were long-time residents of Park City, possibly going back several generations, and were active members of St. Mary's Catholic Church. William and Carol Rixey lived in Salt Lake, but owned an antique store in the Star Hotel in Park City. They might have moved up to Park City later in life, but it is not clear if they actually did or not.
